



United Way of King County Free Tax Campaign, Total Returns



United Way of King County provides free tax preparation and access to the Earned Income Tax Credit and other tax credits to help working families increase their incomes and create savings. The Tax Campaign allows low-income people to keep more of their hard-earned money and avoid paying unnecessary fees for commercial tax preparation and “rapid refund” loans. Being financially stable reduces the risk of becoming homeless.

In 2009, 530 volunteers dedicated over 16,000 hours to United Way of King County’s Free Tax Campaign. Volunteers prepared **13,631** tax returns helping bring **\$17.3 million** in federal refunds back into the community, including more than **\$5.2 million** in Earned Income Tax Credits. The Free Tax Campaign saved customers more than **\$1 million** in tax preparation fees.
